OBTAINING PARKING TAG TO DRIVE ON CAMPUS:

- 1. Student must attend the Nassau County's District Attorney's Choices and Consequences Driving Meeting.
- 2. This form (2022-2023 Senior Driving Guidelines) must be read by the student and parent, signed and dated.
- Student must be 17 years of age and must possess a valid <u>New York State Class D Driver's License</u>.
 DJ license is not acceptable per Jericho High School's rule.
- **4.** The original or copy of the student's <u>D license</u>, <u>car registration(s)</u> of the car(s) to be driven to school, and this form (<u>2022-2023 Senior Driving Guidelines</u>) are to be brought to Mr. Cummings' office to obtain a blue parking tag (Day 1) or a yellow parking tag (Day 2) to hang on the rearview mirror of the car.

SECURITY GUARDS: Security guards are posted in various areas around the school, and it is essential that their instructions be complied with for everyone's safety and consideration.

SCHOOL ADMINISTRATORS: School administrators have the legal responsibility to search if the car is on campus and/or if there is any reason to believe that the car is storing materials which may be dangerous to students.

PARENTS: Parents are to use discretion when inclement weather is forecasted, particularly snow.

RULES, REGULATIONS AND EXPECTATIONS: Students are expected to follow the parking rules, regulations, expectations, and the parking tag's Day 1/Day 2 rotation. If the student violates any of them, parking privileges will either be suspended or revoked as a result.

- If at any time a student loses his/her license or is put on driving probation for any reason, the student and parent are expected to notify Mr. Cummings to meet and discuss the situation.
- **PARKING TAGS ARE NOT TO BE EXCHANGED UNDER ANY CIRCUMSTANCES.** Students found to be tampering with the system will lose driving privileges indefinitely.
- Car windows are to be closed, and car doors are to be locked at all times.
- School closings due to emergencies or weather-related circumstances do not change the rotation of days/color of parking tag as indicated by the schedule. Driving days lost due to school closings cannot be made up at a later date or time.

RULES, REGULATIONS AND EXPECTATIONS (continued):

- Seniors are permitted to drive the registered car to the senior parking lot and directly off campus. Drivers should enter and leave campus through the Route 106 entrance. Any senior in a non-designated space, regardless of weather, will lose his/her parking privileges. Student cars are <u>not</u> to be located in a staff parking lot prior to 4:15 p.m.
- Seniors are not to leave campus at any time during the school day.
- Underclass students are not allowed in any senior's car while it is on campus unless driving to and from school.
- Seniors are not to drive a car registered to another student.
- Car radios are not to be played loudly on campus. If a car radio is reported as disturbing instruction, the senior will be in violation of this agreement.
- Speed limit on school grounds is limited to 15 miles per hour. Drivers are not to pick up or discharge passengers in any area other than the senior lot.
- If there is an accident on school grounds with another car, person or property, it must be reported to Mr. Cummings' office **immediately**.
- Seniors who have illegal absence records will be in serious jeopardy of losing their driving privileges.

ENFORCEMENT PROCEDURES:

SIGN AND DATE BELOW:

- ➤ Tickets will be issued for infractions. Tickets will identify car and infraction, as well as the date and time of the infraction. For non-moving violations, the ticket will be placed on the car; and a copy will be brought to Mr. Cummings' office. The registered driver of that vehicle will be responsible and must report to Mr. Cummings immediately.
- ➤ If the infraction is for a moving violation, the ticket will be written as much as possible by the staff member reporting the infraction. Both parts of the ticket will be given to Mr. Cummings. The student will be called to the office to be informed of the infraction, and the parent will be notified.
- Consequences may range from a warning to temporary or permanent suspension of privileges. If privileges are suspended or removed, the student may not drive to school and park on campus. The student and parent must then meet with a school administrator to restore driving privileges.
- Nassau County police may ticket students at any time for driving infractions and/or illegally parked cars.
